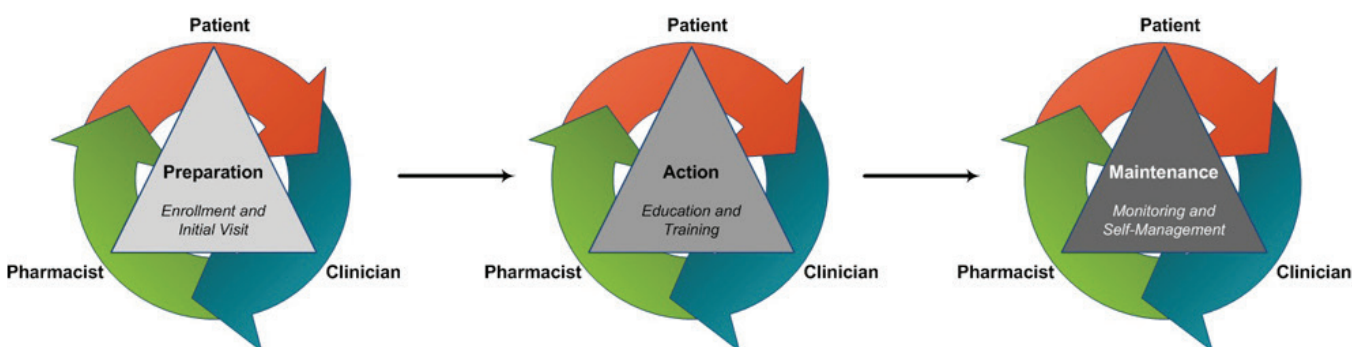

YOU fund APhA Foundation research that gathers the compelling evidence for improved patient care outcomes when pharmacists are part of a multi-disciplinary healthcare team.



In June, APhA and the APhA Foundation joined the National Forum for Heart Disease and Stroke Prevention – along with 20 other organizations representing patients, providers, public health, payers, and purchasers – in issuing a [Joint Policy Statement](#) including recommendations that will expand access to care options for patients nationwide especially those in underserved or otherwise vulnerable populations.

The proposed policy recommendations align with the APhA Foundation’s sustained efforts, like its Project IMPACT initiatives, to demonstrate how pharmacists and other healthcare providers can work collaboratively to facilitate patient access and improve both health outcomes and cost-effective care.

The APhA Foundation’s First Demonstration Project Project IMPACT (Improve Persistence And Compliance with Therapy): Hyperlipidemia

YOUR support 25 years ago resulted in a landmark study that showed the value of an innovative point-of-care technology combined with a process of care that includes collaboration among patients, pharmacists, physicians and other healthcare providers. Results included 93.6% medication persistence at 24 months and 2.5 times the number of high-risk participants who achieved and maintained their lipid goals compared with those in a concurrent trial that did not use the same team-based care process.

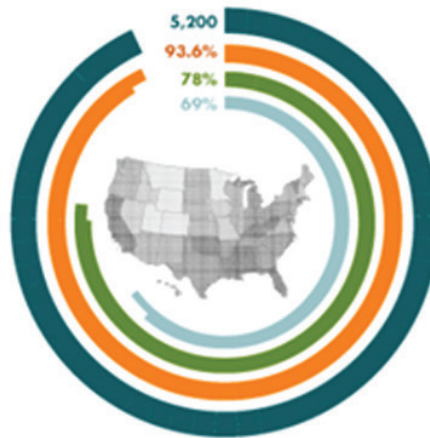

IN 2020, active research and innovation programs included key work in diabetes prevention, cardiovascular health, and contributions to individual and population health.

Blood Pressure First (BP First) is a collaboration between the CDC Foundation and the APhA Foundation on an innovative care model implemented by employers seeking to control hypertension in their workforce. BP First offers the employer's health care beneficiaries the opportunity to engage in pharmacist-delivered blood pressure management programs provided onsite or in their local community pharmacy through the team-based care process. Stay tuned for results of this exciting initiative in 2021.

Through a multiyear collaboration with the American Medical Association (AMA), the APhA Foundation has helped to envision and support the creation of a new **Validated BP Device Listing** of blood pressure measurement devices that have been validated for clinical accuracy through an independent review process. This important work and interprofessional collaboration have resulted in the availability of a universal resource that helps both patients and health care professionals make informed decisions about measurement devices that consistently produce precise and accurate BP results. Project IMPACT: Diabetes Prevention is an opportunity to change the landscape of how the National

Diabetes Prevention Program (DPP) is delivered in communities across the country. Through a cooperative agreement with **CDC** in partnership with **Kroger** and **SinfoníaRx (TRHC)**, this 5-year national program provides a unique multimodal DPP delivery model using teams of lifestyle coaches to meet participants where they are and support their success. This initiative is setting the stage for how pharmacists and pharmacy practice settings can and will be a compelling solution for preventing diabetes in the future.

Solutions for Atrial Fibrillation Advocacy (SAFE) a new APhA demonstration project launched in late 2020, integrates AFib screening, detection, and referral services as a routine component of care in community-based pharmacies.

New **IMPACT Tools for Innovative Practice Sustainability (TIPS)** are being developed to support effective engagement in the new patient care service. These tools

will be designed to support practices in **IMProving America's Communities Together**.

Our work in **Project IMPACT: Immunizations** continues to evolve and helps to address gaps in vaccination coverage that pose a significant risk to public health. The importance of this work was amplified when pharmacists garnered increased recognition during the COVID-19 response. This year important work was also underway on another new initiative, **RxTest.Solutions**, which will include the 2021 launch of the **IMPACT Care Transformation Network**. Our **IMPACT Care Transformation Institute** resources continued to provide a combination of online CPE modules, webinars, and active learning activities.

The APhA Foundation secures a seat at the table where national dialogues about public health and medication use safety occur.

We give an enhanced voice to pharmacy.

- Foundation's participation in the National Forum for Heart Disease and Stroke Prevention (*National Forum*) Value and Access Steering Committee (VASC) virtual meeting to achieve consensus about new initiative priorities for 2020-21
- Presentations and interprofessional education about options for enhancing the role of pharmacists in patient-centered, team-based care work of the National Forum Value and Access Steering Committee
- Meetings, presentations and collaboration with the National Forum to support position statements on the valuable role of pharmacists in team-based care with universal agreement from the Value and Access Steering Committee to include four Federal and two State objectives
- Workgroup meetings with National Forum staff to refine mutually agreed upon positions for Value and Access Steering Committee to utilize in Federal and State advocacy for the role of the pharmacist
- Collaborative meetings with National Forum staff, APhA, NACDS, PQA, and Value and Access Steering Committee to finalize advocacy consensus for COVID-19/patient-centered, team-based care services/payment that includes pharmacists

FACILITATING PHARMACY INNOVATION

Pharmacy innovation begins with an idea. With the generous support of the **Community Pharmacy Foundation**, the Daniel A. Herbert Incentive Grant Endowment, and proceeds from the APhA Foundation Annual Fund, the [APhA Foundation Incentive Grants for Practitioner Innovation in Pharmaceutical Care](#) provides seed funds to pharmacists and student pharmacists to support pioneering projects and concepts that advance patient care services.

This year, the APhA Foundation presented 30 deserving recipients with Incentive Grants. Established in 1994, the APhA Foundation Incentive Grants for Practitioner Innovation in Pharmaceutical Care is the Foundation’s longest-running program. To date, the Foundation had provided support for more than 650 Incentive Grants.

The 2020 Incentive Grant recipients have chosen to address some of today’s most pressing health issues, from mental health to unmet vaccination needs.

INCENTIVE GRANTS PROGRAM

Thanks to you and other donors, The APhA Foundation awards seed money each year that fosters innovative approaches to pharmacist patient care services.

Incentive Grant projects are addressing some of our nation’s most pressing health issues. Below is a sample of their findings from 2020.

PHARMACOGENETICS

Pharmacists who participated in a continuing education course on pharmacogenetics rated themselves significantly more confident in their abilities to interpret pharmacogenetic data, meaning they are better able to advise patients.



CANNABIDIOL (CBD)

Over 75% of pharmacists surveyed agreed that recommending CBD is the job of a pharmacist, but only 37% agreed they were confident counseling on CBD. In another survey, 89% of pharmacists reported managing therapeutic interactions with CBD, showing its relevance to pharmacists today.

MEDICATION ADHERENCE

Regarding missed doses of their inhalers in the past week, 7 (15.9%) patients answered 0 missed doses at the initial visit. After pharmacist intervention focusing on adherence, 27 (61.4%) patients answered 0 missed doses at the 60-day follow-up, a 45.5% increase in inhaler adherence.



NALOXONE

After creating a novel opioid workflow including pharmacists prescribing naloxone, at-home access to naloxone for chronic opioid patients went from 3% in January 2019 to 18% in December 2019, an absolute change of 15%.

DIABETES

Pharmacist-led screenings for diabetes and encouragement to make an appointment with a health care provider resulted in greater patient weight loss (~16 lb in 1 month) and increase in physical activity compared to those who did not make an appointment with a health care provider.

Project Title: Impact of Pharmacist Provision of Naloxone at an Independent Community Pharmacy Operating Under State Naloxone Protocol

Incentive Grant Project Result

Kathryn's goal was to determine if a universal offer to provide naloxone to all patients dispensed an opioid, accompanied by patient counseling, increases naloxone possession rates among patients of an independent community pharmacy. Her secondary objective was to identify factors associated with increased risk of opioid-related overdose that may be common among patients dispensed naloxone at an independent community pharmacy.

Implementation of a naloxone dispensing service at an independent community pharmacy provides an access point within the community to the potentially lifesaving medication. Following implementation of the naloxone dispensing service, 10 patients have received naloxone from the community pharmacy. Fifty percent of these patients received naloxone under the authority of the state's joint protocol for naloxone without a prescription (two additional patients have been dispensed naloxone following the end of the official study period).

The pharmacy is currently a participant in the Flip the Pharmacy practice change initiative. The change packages for the second progression of the initiative focus on the safe use of opioid analgesics. This will address the scalability of the naloxone service, providing additional staff training and standardization of pain medication reviews.

Project Title: Indiana Pharmacists' Perceptions of Diabetes Self-Management Education and Support (DSMES) Diabetes Prevention Program (DPP), or Medication Therapy Management (MTM) Services: A Statewide Study

Incentive Grant Project Result

Kristen's objectives were to determine Indiana pharmacists' interest in starting, expanding, or maintaining DSMES, DPP, and MTM programs and to identify the barriers to developing these programs.

Indiana pharmacists expressed a strong interest in maintaining their current DSMES, DPP, and MTM programs. Lack of interest in developing these programs among some Indiana pharmacists is likely due to perceived barriers (lack of time and payment).

The survey provided specific Indiana pharmacist perceptions of barriers to maintaining, expanding, and developing DSMES, DPP, and MTM services and identified pharmacist interest in these services. The study findings offer important data about barriers that must be overcome to increase these programs across Indiana.

Project Title: Impact of a Community-Based, Pharmacist-Driven Health Coaching Program on Clinical Outcomes and Health-Related Quality of Life

Incentive Grant Project Result

Lauren's research aimed to integrate an innovative health coaching program into the workflow of a chain pharmacy. Her second goal was to evaluate the change in outcomes from the program, including clinical parameters, patient health-related quality of life, and patient perceptions and satisfaction with the service.

Data collected through an anonymous survey indicated that perceptions of pharmacist capabilities changed as a result of this pilot program. Patients saw improved clinical outcomes from pharmacist-led health coaching services and also saw that pharmacists are capable of serving as effective health coaches. This could pave a path for greater recognition and utilization of pharmacists to close the gap in health care. By utilizing pharmacists, who are already centrally located in chain and retail pharmacies, to act as health coaches, patient care can be provided using a whole-person methodology instead of the segmented care currently demonstrated in the American health care system.

The study demonstrated that patients are more likely to reach individualized health goals and see improved health outcomes with the aid of a community-based pharmacist implementing the COACH program. All patients enrolled in the pilot program demonstrated an interest in and willingness to participate when the COACH program resumed in August 2020. Further data are required to prove direct impact of outcome in metrics with the COACH program.

Incentive Grant Project Result

Molly explored pharmacist preceptors' knowledge and experience with CBD products and their perceived intent to recommend these products for patient use. Her secondary study objective was to identify desired resources on CBD products for pharmacists.

She found that the majority of community pharmacist preceptors in this cohort reported having clinical CBD interactions. Despite roughly half of the preceptors surveyed reporting the sale of CBD products in their pharmacies, most respondents did not feel they had reliable CBD resources available in their pharmacies and were not comfortable counseling on CBD products.

To the best of the research team's knowledge, this study is the first to explore community pharmacist preceptors' knowledge, experience, and perceptions of CBD. These findings contribute uniquely to the existing but limited literature on pharmacists and their perceptions of medical cannabis by providing a valuable baseline for what community pharmacists across the United States know and think about CBD as well as what their professional experiences with CBD have looked like thus far. The study results can be used to develop targeted educational materials and shared resources that fill the gaps in pharmacist knowledge and confidence identified by survey results, leading to enhanced provision of care to patients wishing to add CBD products to their medication regimens.

Investing in the Future of Pharmacy

The APhA Foundation Student Scholarship Program

APhA Foundation donors invest in the future of pharmacy by funding scholarships for the next generation of leaders. The APhA Foundation Student Scholarship Program continues to provide meaningful scholarship money to student pharmacists across the country. Year after year, the impact that these scholarships have on students is significant. Students have told us that this money helps them reduce the need for loans, afford attendance at pharmacy conferences, and participate in other educational opportunities that they otherwise could not afford.

In 2020, the APhA Foundation awarded scholarships to 20 deserving student pharmacists to encourage and support them on their journey to a rewarding pharmacy career. Two new fully endowed scholarships were introduced: the Tery L. Baskin Scholarship Endowment and the Dr. Natalie M. Certo Scholarship Fund.



Tery L. Baskin Scholarship Endowment

The APhA Foundation Board of Directors established the **Tery L. Baskin Scholarship** to honor his extraordinary service to the APhA Foundation, APhA, and American pharmacy. Tery lost his battle with cancer in March 2019. Thanks to many generous donors, funds were raised to endow this scholarship in his name. Each year one outstanding student pharmacist will be selected to receive a \$1,000 scholarship. The inaugural Tery L. Baskin Scholarship will be awarded in spring 2021.



Dr. Natalie M. Certo Scholarship Fund

The **Dr. Natalie M. Certo Scholarship Fund** was established in memoriam, by her sister and fellow pharmacist, Josephine Certo. Natalie dedicated her life to pharmacy. She worked in community pharmacies, taught at the University of Pittsburgh School of Pharmacy, and was the director of the Children's Hospital of Pittsburgh Pharmacy Service. An APhA member since 1957, Natalie served in various capacities and considered her service as APhA Board of Trustee (1981-84) the biggest honor of her career. The Certo scholarship will be awarded each year to an APhA student member who demonstrates a record of engagement and academic achievement. Applications will be accepted in Fall 2021, for a \$1,000 scholarship to be awarded beginning in 2022.
